Short term Notice inviting Tenders/Rates for Star Artists for Cultural Nights during International Summer Festival-2017.

A notice is hereby given to the Event Managers/Event Management firms to quote rates of play back singer, Laughter Artists, Punjabi, Sufi/Ghazal Artists, Indian Idol/Sa-re-ga-ma-pa winners etc. inclusive all expenses. The Tender should clearly show the breakup of expenditure and submit their financial bids on or before 20-05-2017 up to 3:00 PM. The Tenders/rates will be opened in the Chamber of Additional District Magistrate (L&O), Shimla on 20-05-2016 AT 3.30 PM. All the interested participants are requested to be present in person or through their representatives on the above said date, time and place. The terms and conditions shall be as under:-

1. The participants must have wide experience in the field and shall submit in brief the details of events conducted by them in last two years (2015 & 2016). They shall submit their PAN no. copy and Income Tax Returns of last two assessment years.
2. All interested participants shall have to furnish an earnest money in the shape of Bank Draft of Rs. 50,000/- in the name of Deputy Commissioner -cum-Chairman, Shimla Summer Festival Committee, Shimla, H.P.
3. List of panel of Star artists shall be disclosed to all the participants on same day at 2:00 PM.
4. The lowest rates of each artists/performer shall be accepted, subject to the confirmation as mentioned at Sr. No. 1, 2& 3 and condition mentioned at Sr. No. 1
5. The Tendered/Party whose rates will be accepted shall have to execute an agreement with the Additional District Magistrate (L&O), Shimla to the effect that artist/performer shall be provided on the schedule date and time. In case of failure to do so, the concerned party shall be liable to pay double the amount of honorarium payable to the artist to the Shimla Summer Festival Committee as penalty and earnest money in the form of Bank Draft shall also stand forfeited.
6. The terms of payments shall be settled mutually by the Shimla Summer Festival Committee and Event Manager.
7. The undersigned reserves the right to reject any tender/rates without assigning any reasons thereto.
