- 1) Conditional tender shall not be considered
- 2) The rate to be quoted should be per day per item for five days.
- 3) The supplier will be responsible himself for the custody and safety of items supplied by him.
- 4) The tender in two forms (See instruction no. 7) shall be submitted in sealed envelopes in the name of Chairman, International Shimla Summer Festival Committee –cum-D.C., Shimla.
- 5) The tender form shall be issued to those firms only who have completed at least two works of similar nature earlier.
- 6) The Chairman reserves the right to accept or reject any or all the tenders without assigning any reason.

- 7) The tender shall be accompanied by earnest money of Rs. 30,000/- (Rupees thirty thousand) only, each for item no. 1 to 3 and Rs. 10,000/- (Rupees ten thousand only) for item no. 4 in shape of Demand Draft before submission of tender in favour of Chairman International Shimla Summer Festival Committee –cum-D. C. Shimla.
- 8) Successful tenderer shall deposit a sum of Rs. 1,00,000/- (Rupees One Lac) only in shape of F.D.R only as security money within seven days from the receipt of the acceptance of the tenderer. Earnest money for 30,000/- and Rs. 10,000/- will be adjusted as security money in case of successful tenderer.
- 9) If successful tenderer fails, neglects, declines or otherwise not executing the same in time and in accordance with the terms of the contract, the chairman Shimla Summer Festival Committee shall be at liberty to arrange all such items from open market and any excess cost so incurred over the contract price shall be recoverable from successful tenderer.
- 10) The tender shall be submitted in two separate sealed envelopes for separate items. Envelop “A” will contain profile of the company alongwith past experience and quality of the supplies intended to be rented out. Envelop “B” will contain financial quotation of tender items. Only in case quality of the supplies and company profile is found suitable the financial bid will be opened.
